# Midas X Blockchain Privacy Policy

Policy describes Demiourgos This Privacy how Holding SA and its affiliates ("Demiourgos.Holdings") collect, use, and disclose information about you in connection with your use of the Services and access to the Website, including when you use or interact with the Services, request to receive updates from us, post in community features of the Website, or otherwise communicate with us through any channel. Unless specifically defined in this Privacy Policy, all capitalized terms have the meaning given to them in the Terms of Use. This Privacy Policy does not apply to any products, services, websites, or content that are offered by third parties or have their own privacy policy.

## 1. What information do we receive from you or collect?

## Information You Give Us

The information we receive from you depends on the specific information you choose to give us. You may choose to give us that information in various contexts, such as filling out a form; participating in a event or other activity; requesting support; and signing up for email alerts and newsletters. The type of information you choose to give us may include:

- ⇒ **Identity Information**. First and last name, username, and other identifiers you give us.
- ⇒ **Contact Information.** Email address and any other contact information you provide us.
- ⇒ **Marketing Information.** Your preferences, including preferences for receiving marketing communications from us and how you interact with our marketing communications.

- ⇒ **Social Media Information**. Your unique handle or identifier and other profile information when you interact with us through Twitter, Discord, Slack, Telegram or other channels.

## Information Collected Automatically

We make a concerted effort to limit the information we collect about you through automated means. We may, however, automatically collect certain limited types of information when you access, use, or interact with the Services or the Website, such as:

- ⇒ **Device Data**. Device data including device type (e.g., desktop, mobile, tablet), browser type and version, and operating system and version for the limited purpose of debugging front end issues.
- ⇒ **Blockchain Data**. Public blockchain data including blockchain addresses and crypto-asset transaction information related to those blockchain addresses.
- ⇒ **Aggregate Data**. Analytics about aggregate numbers of users and usage types (i.e., number of page views, event counts, and aggregate acquisition metrics), and information such as how many users in the aggregate are using certain protocols with assistance of

Services; and aggregate location data across users including countries and regions from which users access the Services or the Website.

## Information from Third Parties

We may receive additional information about you from third parties we work with (including, contractors, project partners, service providers, and analytics providers). This information may be combined with other information you provide to us or that we automatically collect.

#### 2. How We Use Information

We use information about you to:

- a) Enable you to access and use certain Services or features of the Website.
- b) Provide and deliver products, Services, or experiences you have requested.
- c) Maintain and improve the Services or the Website.
- d) Personalize your experience with the Services and the Website.
- e) Facilitate events and provide information to you about events.
- f) Send information including technical notices, updates, security alerts, and administrative communications.
- g) Provide support for the Services including resolving issues and responding to your questions and Feedback.
- h) Comply with law if we have a legal obligation to collect, use or retain information about you or comply with legal requests like subpoenas or requests from government authorities.
- i) Be responsive to you, to provide you effective Services, and to maintain our business relationship with you and others.
- j) Market and promote certain Services, offerings, events, or experiences to you.
- k) Prevent, detect, and investigate fraudulent, abusive, or harmful activities.
- l) Analyze usage trends and determine efficacy of promotional or marketing campaigns.
- m) Enforce the Terms of Use or other policies.

We may use or share information about you with your consent, such as when you allow us to post your testimonials or endorsements of the Services in any medium including Twitter, you instruct us to take a specific action with respect to your personal information, or you opt in to receive marketing communications from us or third parties.

## 3. How We Share Information

Transactions Involving Third Parties

We may make available to you services, software, and content provided by third parties for use on or through the Services or the Website. Please consult the third party's privacy policy for information about how the third party handles your personal information.

#### Service Providers
